### Facilitator

The presence of a church member/facilitator may be required for rentals of the Sanctuary and Atherton Hall.

Weddings / Spiritual Unions: \$150 (required)

\*\*In order to be eligible for the member rate, the person renting the space or getting married must be a pledging member “in good standing” for at least one year with a paid-up pledge. For those who have not been members of the church for one year, the non-member rate shall prevail. In case of hardship or a pledging friend, these requirements can be waived or the fees lowered by the Minister or Board President.
